CCA Council Delegates:

The CCA Legislation and Political Action Committee discussed 11 bills at the February and April CTA State Councils and took the following positions. These positions will be brought to CCA Council for a vote:

AB 63 (Donnelly) – Repeal the Dream Act. **OPPOSE**

AB 130 (Cedillo) -- Include technical/adult school graduates in eligibility for Dream Act. **SUPPORT**

AB 383 (Portantino) – Overload not to exceed 50% per semester. Stipend for bargaining this. **WATCH**

AB 131 (Cedillo) – Dream Act students eligible for CA financial aid. **SUPPORT**

AB 478 (Hernandez, Roger) Removes the current 2% positive differential between the California unemployment and a rate of 5% as it relates to funding community college FTES. **WATCH**

AB 515 (Brownley) – Extension programs at CCs offer credit courses. **OPPOSE**

AB 620 (Block) –Rules on student harassment, bullying, intimidation. **SUPPORT**

AB 661 (Block) – 8 year pilot on baccalaureate programs at San Diego CCD.
WATCH

AB 743 (Block) –Common assessment instruments leading to common state standards. **OPPOSE**

AB 835 (Mitchell) – Enrolling HS students who are not residents of CC district. Excused absences from HS classes. **WATCH**

AB 965 (Dickinson) – Districts required to use apportionment funds to reach 75% instruction taught by full time faculty. **SUPPORT**

SB 8 (Yee) -- Public Records --transparency for foundations/auxiliaries.
SUPPORT

SB 114 (Yee) – Unified salary schedule FT/PT. **SUPPORT**

SB 292 (Padilla) – CSU required to admit CC students with Associate Transfer degree. Priority enrollment. **WATCH**

SB 295 (Price) – Removal of prohibition on sites for CCs that are fewer than 2 miles from airport runway. **WATCH**

SB 650 (Lowenthal) -- Admission of LBUSD high school students to LBCC. LBCC receives apportionment. Funding through endowment. May include priority enrollment for some HS students. **WATCH**

The **WATCH** position means that we will be working with the author to clarify aspects of the legislation.

CO-SPONSORED LEGISLATION

AB 852 (Fong) -- The Legislation Committee also agreed to a **SUPPORT** position for this bill on Part-Time/Adjunct Rehire Rights and will advocate for co-sponsorship on this bill when it is requested.
