AB 581/ Tom Torlakson	Requires the CA Community College Chancellor's Office to conduct annual random audits of five Community College Districts for compliance with the Fifty Percent Law.	Assembly Appropriations Committee
AB 1095/ Jerry Hill	Ensures full compliance of law that mandates 75% of instruction be performed by full time faculty in California Community Colleges within three years of passage.	Assembly Appropriations Committee
